Review of the Companies Act

In October 2007, The Ministry of Finance (MOF) had set up a Steering Committee to carry out a fundamental review of the Companies Act (Chapter 50). The review is aimed at ensuring an efficient and transparent corporate regulatory framework that supports Singapore's growth as an international hub for both businesses and investors.

The Steering Committee's Report comprises six chapters and 217 recommendations:

- (a) Chapter 1 – Directors;
- (b) Chapter 2 – Shareholders' Rights and Meetings;
- (c) Chapter 3 – Shares, Debentures, Capital Maintenance, Schemes, Compulsory Acquisitions and Amalgamations;
- (d) Chapter 4 – Accounts and Audit;
- (e) Chapter 5 – General Company Administration; and
- (f) Chapter 6 – Registration of Charges.

Consultation on the Regulatory Framework for Foreign Entities in Singapore

The public consultation on the proposals relating to foreign entities is launched concurrently to provide the public with a comprehensive view of the proposed changes to the Companies Act total of 40 recommendations.
